Fine Arts Building Renovation

- Pre-qualification of potential trade contractors
 - 203 proposals received
 - 113 prequalified for 33 bid packages; electrical package was reissued
- Working Drawings to CCCCO in November; approval for bidding received on May 19.
- Phase 1 Move to Swing Space began May 22 and Phase 2 will occur in late July to be operational by Fall 2023.

- Three separate DSA approvals have been received for Parking Lot 1, Dining/Restroom, and Kitchen packages.
- Purchase Orders completed for leasing of the kitchen units from Mobile Kitchen (MK) and Dining/Restroom units from Global Modular (GM).
- Orange County Health Care Agency approval was received March 29, 2023 for the modular kitchen.
- Bid documents have been posted for the second and third packages prior to DSA approval to maintain scheduled completion.
- Off-site modifications of the modular buildings are underway by GB and MK.
- Budget has been augmented by \$1M from local capital outlay funds

Updates on campus projects - Fullerton College

Renovate Building 300

- DSA Backcheck complete. Project Documents approved on May 30; CGS completed its review of the construction documents and agreed with the supports use of micropiles and caissons to strengthen the foundation.
- Westberg White is working on an updated estimate of probable construction cost
- CCCCO will review approved documents and provide authorization to bid for general contractor (GC) in the upcoming months. GC prequalification underway.

- DSA approval for Construction Documents received for the New M&O project. Approval for the Chapman/Newell is anticipated in early June.
- An amendment to the pre-construction agreement was approved to release funds for items with long lead times by the BOT at the March 28 meeting.
- The Campus Project Team is coordinating with the City of Fullerton Public Works Agency to address the scope of work for the right-of-way improvements.

New Performing Arts Complex & Demolition Buildings 1100 and 1300

- Project Construction Documents under review at DSA
- Pfeiffer completed responses to Builder User Groups comments on the 100% CDs.
- Specialty Contractor RFQ posted in April and the deadline for proposals was extended to May 11.
- The Building User Groups concluded reviewing outstanding comments for Pfeiffer. Edits to be incorporated during DSA backcheck



Updates on campus projects - Fullerton College

Wilshire Chiller Plant Relocation

- 100% CDs will be submitted in two increments. Increment 1 was re-submitted to DSA in February and successfully in March. First round of Fire and Life Safety review completed April 5.
- Increment 2 for the Arts Yard is scheduled for submission to DSA in June. It contains an ADA path of travel and restroom for the New Performing Arts Complex.
- Construction start is anticipated in Fall 2023.

New Welcome Center & Lot C West

- The Campus Project Team worked with Westberg White on preliminary assessments.
- A probable project cost of \$64M has been determined by Westberg White
- Planned execution under a Design-Build entity with a selection process anticipated in 2024.
- Construction activities anticipated in 2026 after demolition of Bldgs 1100 and 1300.

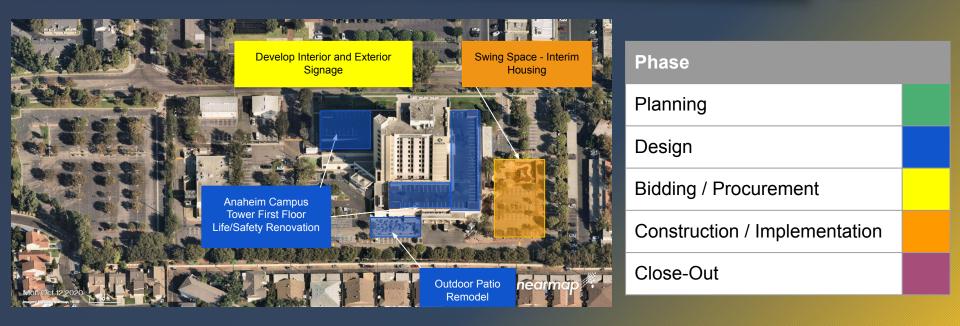

- \$669k added for infrastructure improvements
- RT Contractor selected as lowest responsible bidder and BOT approval of the Purchase Order in March.
- A construction kick-off meeting was held on April 4. Site grading and utility activities are underway.

Anaheim Campus Tower First Floor Life/Safety Renovation

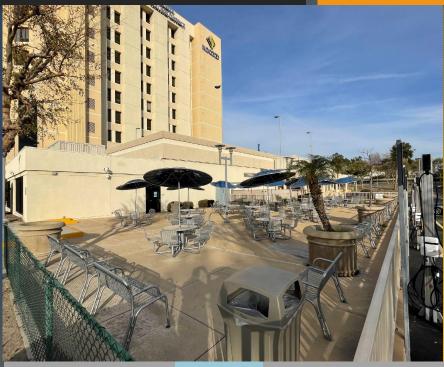
- DSA submission under review with approval anticipated by June.
